- That they pay their employees fair wages.
- That they do not practice child labour.
- That they act in the most environmentally friendly way including use of recyclable packaging material.
- Not to solicit favourable terms for their company by giving monetary or other forms of inducements to our employees.
- Not to accept money or other forms from our employees for favourable treatment.
